a. Employee Contract Negotiations – Exempt

Counselor Montenegro stated, "Unless someone wants to continue the discussion or bring a motion to have a commissioner join with the executive director to negotiate. If that motion is seconded then it gets a roll vote."

Chairman Cevasco stated, "I make a motion that at least one commissioner be assigned to the negotiating team for this Authority."

Counselor Montengro asked, "Is there a second?"
