#### 6. OTHER BUSINESS

Director Specht stated, "Thank you for attending to this today. I sent an email out to the Board about the purchase and installation of a valve insertion on Silver Sands way. We discovered a minor leak this time that we hope won't develop into a major leak on Vanessa Drive. It is important that we get this insertion valve installed to minimize any sort of shut down for our customers. Shut down without the insertion valve will be about 75 residential and 1 business. With the insertion valve it will only be about five customers. We got three quotes and the low quote was from Cutter Drill and Machine, Inc. for \$5,339.25."

Comm. Fozman asked, "How long will this job take? Is it a one day job?"

Director Specht replied, "It is one day. We will excavate and then Cutter will insert the valve and provide the labor to insert it."

Comm. Lydecker asked, "Is the labor included in this price? How much is the actual valve?"

Director Specht replied, "I have a quote for a price that includes valve and labor in the amount of \$5,339.25. I would say the valve is probably half that cost."
