

## RESOLUTION NO. 12-10

### THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY

February 1, 2010

*A resolution Appointing the legal firm of Mulvaney, Coronato, Brady & Kunz, and the legal firm of R.C. Shea & Associates as the Alternate Legal Counsels of The Brick Township Municipal Utilities Authority for the period February 1, 2010 through January 31, 2011.*

WHEREAS, there exists a need for legal counsel and representation by the Brick Township Municipal Utilities Authority (The "Authority"); and

WHEREAS, in accordance with N.J.S.A. 19:44A-20-5 et. seq. (New Jersey Pay to Play Law), the Authority advertised in its official paper a Notice of Solicitation for RFQ's, and

WHEREAS, on January 27, 2010 the duly advertised date for receipt of RFQ's, the Authority opened and reviewed all Qualifications from interested parties; and

WHEREAS, at the Annual Reorganization of the Authority on February 1, 2010, the Board of Commissioners did duly accept the appointment of firms to fill these positions, and

WHEREAS, the Authority is desirous of employing the *legal firm of Coronato, Brady & Kunz, and the legal firm of R.C. Shea & Associates* for these positions; and

WHEREAS, N.J.S.A. 40A:11-5(1)(a)(i) permits the award of contracts for such professional services without public bidding:

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY, as follows:

1. Coronato, Brady & Kunz, 12 Madison Avenue, PO Box 4990, Toms River, NJ 09754, and the legal firm of R.C. Shea & Associates, 244 Main Street, CN2627, Toms River, New Jersey 08754 is hereby appointed as the alternate legal counsels to the Brick Township Municipal Utilities Authority from February 1, 2010 until February 1, 2011 or until the first meeting of the Authority after such date.
2. The Authority Chairman and Secretary are hereby authorized and directed to execute the attached agreements for professional services with said firm which includes a fee on an hourly basis at the rate of \$175.00 per hour, which agreements are made a part hereof.
3. The Authority Chairman and Secretary are hereby authorized and directed to execute an Agreement for professional services with said attorney.
4. The legal firm of Coronato, Brady & Kunz, and the legal firm of R.C. Shea & Associates shall maintain at all times during the term of this employment adequate Professional Liability Insurance including, but not limited to, an Errors and Omissions Policy in an amount not less than \$1 million.
5. This contract is awarded without competitive bidding as a "professional service" in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts Law.
6. The Executive Director shall cause notice of award of said appointment to be published once in the *official newspapers of the Authority*.
