A Resolution Authorizing the Brick Township Municipal Utilities Authority to award the Contract for Renewal of SCADA Ifix/Historian Software Support to Industrial Control Distributors in an Amount Not to Exceed \$25,165.00

WHEREAS, the Brick Township Municipal Utilities Authority (the "Authority") provides drinking water to over 100,000 residents in four (4) communities; and

WHEREAS, the Authority employs a state of the art Supervisory Control and Data Acquisition (SCADA) system to operate its facilities; and

WHEREAS, the General Electric Global Care System is the program used by the Authority to maintain and trouble-shoot problems with the SDADA system; and

WHEREAS, Industrial Controls Distributors of Wanamassa, New Jersey, is the only authorized vendor to provide support and services for the General Electric Global Care System; and

WHEREAS, we have received a quote from Industrial Controls Distributors for three (3) years for the General Electric Global Care System service and support contract for a total of \$25,165.00; and

WHEREAS, Frank Planko, Chief Financial Office for the Authority, has certified that there are sufficient funds for the payment of this contract within Operating Account No. 917-8703 for fiscal year 2010/2011 payments.

NOW, THEREFORE, BE IT RESOLVED this 21st day of June, 2010, by the Commissioners of the Brick Township Municipal Utilities Authority as follows:

- The Authority accepts the proposal for a three (3) year service contract for SCADA Global Support System presented by Industrial Controls Distributors (attached as Schedule A).
- 2. The Director of Central Services is authorized to execute all documents necessary to place the Contract into effect.
- 3. Amounts not to exceed \$25,165.00 shall be charged to Operating Account No. 917-8703 over the three (3) year term for the payment of the obligation provided for herein.
