- 2. The Authority hereby approves the attached Employment Agreement with James F. Lacey, a true copy of which is on file at the office of the Executive Director and can be reviewed during normal business hours.
- The Chairman and Secretary are hereby authorized and directed to execute the attached Employment Agreement with James F. Lacey in the form attached hereto.
