A Resolution Authorizing the Final Quantities Change Order/Change Order No. 2 in the Contract between the Brick Township Municipal Utilities Authority and Caruso Excavating Inc. for a Decrease in the Contract Amount by \$9,100.00 for Contract No. 805001 – Parallel Gravity Sewer under the Garden State Parkway, New Jersey Environmental Infrastructure Financing Program (NJEIFP), Project No. S340448-08

WHEREAS, The Brick Township Municipal Utilities Authority (the "Brick Utilities") did enter into a contract with Caruso Excavating, Inc. for work associated with the installation of a 12" diameter sanitary sewer main parallel to the existing main under the Garden State Parkway, Contract No. 805001, which contract was authorized by Resolution No. 42-10; and

WHEREAS, the Parallel Gravity Sewer Main Project is a unit price contract resulting in the need for a final quantities change order; and

WHEREAS, said changes are shown on a document entitled, Final Quantities Change Order/Change Order No. 2 dated March 28, 2011; and

WHEREAS, said change order provides for a decrease of \$9,100.00 from the previously approved revised contract amount of \$518,572.80 resulting in the final contract amount of \$509,472.80; and

WHEREAS, Brick Utilities and Caruso Excavating, Inc. have agreed to such changes; and

WHEREAS, said decrease amount is fair and reasonable and could not have been foreseen when the contract was advertised and awarded; and

WHEREAS, the Parallel Gravity Sewer Main under the Garden State Parkway is being financed with assistance from the New Jersey Environmental Infrastructure Financing Program ("NJEIFP"); and

WHEREAS, the NJEIFP must review and approve the Final Quantities Change Order; and

WHEREAS, Brick Utilities' Director of Engineering/Operations, Stephen T. Specht, P.E., has reviewed this change order and is recommending that it be approved; and

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF BRICK UTILITIES as follows:

- The contract between Brick Utilities and Caruso Excavating, Inc. is amended and the change order entitled, Final Quantities Change Order/Change Order No. 2 dated March 28, 2011 may be executed by the officers and employees of Brick Utilities upon an execution of such change order by the appropriate officials of Caruso Excavating, Inc; and
- A certified copy of this resolution shall be forwarded to Caruso Excavating, Inc and the NJEIFP.
