A Resolution Awarding Contract for Electrical Work

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has solicited bids for the supply of electrical work on an annual basis (hereinafter referred to as the "contract"); and

WHEREAS, bids have been solicited by the Authority for the contract in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, the three (3) lowest bids received by the Authority in response to the bid solicitation are as follows:


2. The Chairman, Executive Director and Secretary of the Authority be and hereby are authorized to execute any and all necessary documents in order to implement the intent of this resolution.
