A Resolution Authorizing Acceptance and Execution of a Lease Agreement with Trinity Bible Church

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has entered into negotiations with Trinity Bible Church ("Trinity") concerning a Lease of a portion of the parking lot owned by Trinity located on Allenwood-Lakewood Road, Allenwood, New Jersey (the "Property"); and

WHEREAS, the purpose of the Lease is to authorize utilization of parking spaces on the property in order to provide assistance to the public who enjoy use of the Authority's Reservoir Facility.; and

WHEREAS, the Authority has determined that use of the Reservoir Facility by the public has caused an overflow of parking, thereby necessitating the Authority to attempt to find additional parking facilities in order to accommodate the public; and

WHEREAS, a proposed Lease Agreement has been conceptually entered into by and between Trinity and the Authority; and

WHEREAS, the Authority finds that the consideration to be paid by the Authority to secure utilization of the parking spaces on the property is fair and reasonable, and will not cause an unnecessary impact on the Authority or its ratepayers; and

WHEREAS, the Authority believes that entering into the Lease Agreement and thereby securing additional parking spaces for the public is in the long term best interest of the Authority, and the citizens of the Township of Brick and the Counties of Ocean and Monmouth.

NOW, THEREFORE, BE IT RESOLVED this day of June, 2011, by the Brick Township Municipal Utilities Authority as follows:
