A Resolution Appointing and Authorizing the firm of Holman Frenia to Conduct Arbitrage Calculations on behalf of the Brick Township Municipal Utilities Authority

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") believes it necessary and appropriate to undertake an Arbitrage Calculation in order to confirm that the Authority is in compliance with Internal revenue Service Rules and Regulation; and

**WHEREAS**, the Authority has previously appointed the Auditing Firm of Holman Frenia to undertake normal auditing responsibilities for the Authority; and

**WHEREAS**, the Firm of Homan Frenia is familiar with the professional responsibility of undertaking Arbitrage Calculations for municipal entities, in order to insure IRS compliance; and

**WHEREAS**, Holman Frenia has presented a proposal to undertake this service which includes compensation not to exceed \$13,500.00 for the following bond periods: a). The 1998 refunding issue for the five year period ended at the 2003 bond anniversary date b). The 2002 bond issue through the 2010 anniversary date; and

**WHEREAS**, if it is determined that the 1998 refunding issue is close to a positive arbitrage position at the 2003 anniversary date, an additional five year calculation can be performed through the 2008 anniversary date at an additional fee of \$3,500; and

**WHEREAS**, the Authority has made the appointment of Holman Frenia pursuant to the Open and Fair Process:
