A Resolution Modifying Resolution 36-11 Adopted by the Brick Township Municipal Utilities Authority on June 27, 2011

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has adopted Resolution No. 36-11 on June 27, 2011; and

**WHEREAS**, the Authority wishes to modify the aforementioned Resolution; and

**WHEREAS**, the Authority believes that modifying the aforementioned Resolution would be in the long term best interests of the Authority, its ratepayers and customers, as well as the citizens of the Township of Brick; and

**NOW, THEREFORE, BE IT RESOLVED** this 3<sup>rd</sup> day of August 2011, by the Brick Township Municipal Utilities Authority as follows:

- 1. The Authority hereby modifies and revises Resolution 36-11 adopted on June 27, 2011 as follows:
- A. The Authority establishes a procedure for conducting public portions of its meetings which will include the following:
- a. Every speaker will give his/her full name and the municipality in which he/she resides. It will be requested but not required that the speaker give his/her home address, including street address.
- b. Every speaker shall be limited to no more than five (5) minutes. At the discretion of the Chairman, after the remainder of the public has concluded its business, a speaker who has already exhausted his/her five (5) minutes of speaking, can be called upon to speak again for an additional but no more than five (5) minutes.
- c. At the open of each public session of a meeting, the Chairman shall announce the policy hereby established by the Authority.
