A Resolution Authorizing the Brick Township Municipal Utilities Authority to Purchase a Telephone System from Carousel Industries on an Emergency Basis in an Amount Not to Exceed \$41, 449.30

WHEREAS, the Brick Township Municipal Utilities Authority (the "Authority") provides drinking water to over 100,000 residents in four (4) communities;

WHEREAS, the telephone system operated by the Authority is a critical tool necessary to perform its business functions; and

WHEREAS, the severe lightning storm of July 29, 2011, caused irreparable damage to the main controls of the Authority telephone system; and

WHEREAS, the Director of Central Services has received a quote from Carousel Industries to replace the telephone system with a comparable system, the Avaya IP Office 500 System; and

WHEREAS, the price quoted by Carousel Industries to replace the current telephone system with the Avaya IP Office 500 System is \$41,449.30; and

WHEREAS, the Carousel Industries is a state contract vendor for the Avaya IP Office 500 System; and

WHEREAS, the Authority desires to accept the price quoted by Carousel Industries to replace the current telephone system with the Avaya IP Office 500 System; and

WHEREAS, Frank Planko, Chief Financial Office for the Authority, has certified that there are sufficient funds for the payment of this contract within Capital Project No. 910005 in the amount of \$41,449.30.

NOW, THEREFORE, BE IT RESOLVED this 2nd day of August, 2011, by the Commissioners of the Brick Township Municipal Utilities Authority as follows:

- 1. The Authority accepts the quote of \$41,449.30 from Carousel Industries for the replacement of the current telephone system with the Avaya IP Office 500 System.
- 2. The Director of Central Services is authorized to execute all documents necessary to place the Contract into effect.
- 3. An amount not to exceed \$41,449.30 shall be charged to Capital Project No. 910005 for the payment of the obligation provided for herein.
