A Resolution Authorizing Execution of a Shared Services Agreement with the Borough of Bay Head for Design and Construction Management Services for the Route 35 Sewer Lateral Clean-Out Installation Project in the Borough of Bay Head

WHEREAS, the Authority submitted a proposal dated April 6, 2011 for the Borough for a not-to-exceed amount totaling \$50,343.00 which includes the following:

- DESIGN SERVICES (including field surveys and the preparation of bid specifications and bid drawings) for \$11,955.00; and
- CONSTRUCTION MANAGEMENT SERVICES (including bidding services, construction administration, inspection, record drawings and contractor close-out) for \$38,388.00.

WHEREAS, the Borough approved and executed the Shared Services Agreement on August 1, 2011 under Borough Resolution No. 2011-81; and

WHEREAS, a the proposed Shared Services Agreement has been reviewed by the Commissioners and the Authority staff and found to be acceptable as to form and content:

NOW, THEREFORE, BE IT RESOLVED this 22nd day of August, 2011, by the Brick Township Municipal Utilities Authority as follows:

- 1. The Authority accepts and approves the Shared Service Agreement with the Borough of Bay Head, a true copy of which is on file at the Authority office and can be reviewed by the public during normal business hours;
- 2. The Authority will forward a copy of this Resolution and an executed copy of the Route 35 Sewer Lateral Clean-Out Installation Project Shared Services Agreement to the Township of Brick for their approval;
- 3. The Authority authorizes and directs the Chairman, Secretary and Executive Director to execute any and all necessary documents in order to implement the intent of this Resolution;
