A Resolution Authorizing Change Order No. 3 for an Increase in the Contract Amount of \$1,988.61 to Stacey Contracting, Inc. for Contract No. 897087K - Sanitary Sewer Replacement – Phase VI, New Jersey Environmental Infrastructure Financing Program, Project No. S340448-06, Contract 3B

WHEREAS, the Brick Township Municipal Utilities Authority (the "Authority") did enter into a contract with Stacey Contracting, Inc. ("Stacey Contracting") for work associated with the Sanitary Sewer Replacement – Phase VI; Contract No. 897087K which contract was authorized by Resolution No. 03-10; and

WHEREAS, there were two previous Change Order Nos. 1 and 2 which increased the contract amount and were authorized by Resolution No. 67-10 and Resolution 35-11; and

WHEREAS, there have been material changes to the project which have necessitated a change order; and

WHEREAS, said changes are shown on a document entitled Change Order No. 3 dated December 7, 2011; and

WHEREAS, said change order provides for an increase of \$ 1,988.62 from previously approved amended contract amount of \$835,138.00 resulting in a new contract amount of \$837,126.61;

WHEREAS, the Authority and Stacey Contracting have agreed to such changes; and

WHEREAS, said increased amount is fair and reasonable and could not have been foreseen when the contract was advertised and awarded; and

WHEREAS, the Sanitary Sewer Replacement – Phase VI Contract is being financed with assistance from the New Jersey Environmental Infrastructure Financing Program ("NJEIFP"); and

WHEREAS, the NJEIFP must review and approve the Change Order No. 3; and

WHEREAS, the Authority's Director of Engineering/Operations, Stephen T. Specht has reviewed this change order and is recommending that it be approved; and

WHEREAS, the Authority's Chief Financial Officer, Frank Planko, has advised the Authority that sufficient funds for payment of \$1,988.61 does exist in Project No. 897087K to be drawn from the NJEIFP Series 2002.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Brick Township Municipal Utilities as follows:

- The contract between the Authority and Stacey Contracting is amended and the change order entitled
 Change Order No. 3 dated December 7, 2011 may be executed by the officers and employees of the
 Authority upon an execution of such change order by the appropriate officials of Stacey Contracting;
 and
- 2. A certified copy of this resolution shall be forwarded to Stacey Contracting and to the NJEIFP.
