A Resolution for the Award of Bid for Road Patch Materials

WHEREAS, The Brick Township Municipal Utilities Authority ("Brick Utilities"), pursuant to Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. duly advertised for road patch materials; and

WHEREAS, six bids were received pursuant to the advertisement and publicly opened on February 2, 2012 at 2:00 p.m.; and

WHEREAS, said bids and a recommendation from Stephen Specht, P.E., Deputy Executive Director and Director of Engineering/Operations, have been reviewed by the Brick Utilities and bid packages having been submitted for the review of Jerry Dasti of Dasti, Murphy, McGuckin, Ulkay, Cherkos & Connors, General Counsel to Brick Utilities; and

WHEREAS, the bid of Stavola Asphalt Company for Item No. 1 (Crushed Stone Conforming to #57 Coarse Aggregate – Blue Stone @ \$19.75/ton) was the lowest responsive responsible bid submitted and should therefore be awarded; and

WHEREAS, the bid of Trap Rock Industries, Inc. for Item No. 2 (3/4" Quarry Process Stone @ \$15.70/ton) was the lowest responsive responsible bid submitted and should therefore be awarded; and

WHEREAS, the bid of Asphalt Paving Systems, Inc. for Item No. 3 (Asphalt Cut Back @ \$50.00/can) was the lowest responsive responsible bid submitted and should therefore be awarded; and

WHEREAS, the bid of Central Jersey Hot Mix Asphalt, LLC for Item No. 4 (FABC Mix #5 @ \$62.97/ton), Item No. 5 (Stabilized Base @ \$59.97/ton) and Item No. 6 (Cold Patch – High Performance @ \$135.97/ton) were the lowest responsive responsible bids submitted and should therefore be awarded; and

WHEREAS, the term of the Contract with Stavola Asphalt Company, Trap Rock Industries, Inc., Asphalt Paving Systems, Inc., and Central Jersey Hot Mix Asphalt, LLC shall be from April 1, 2012 through March 31, 2013; and

WHEREAS, Frank Planko, Chief Financial Officer, has advised Brick Utilities that funding for payment up to \$12,000.00 does exist and is included in Project No. 610007 of the Fiscal Year 2012/2013 Capital Budget, up to \$5,000.00 does exist and is included in Project No. 610010 of the Fiscal Year 2012/2013 Capital Budget, up to \$22,000.00 does exist and is included in Operating Account No. 703-8090 of the Fiscal Year 2012/2013 Operating Budget, up to \$20,000.00 does exist and is included in Operating Account No. 703-8070 of the Fiscal Year 2012/2013 Operating Budget, up to \$13,000.00 does exist and is included in Operating Account No. 803-8090 of the Fiscal Year 2012/2013 Operating Budget, up to \$13,000.00 does exist and is included in Operating Account No. 803-8070 of the Fiscal Year 2012/2013 Operating Budget, up to \$3,500.00 does exist and is included in Operating Account No. 711-8090 of the Fiscal Year 2012/2013 Operating Budget and up to \$1,500.00 does exist and is included in Operating Account No. 711-8070 of the Fiscal Year 2011/2012 Operating Budget.


NOW THEREFORE, BE IT RESOLVED BY the Brick Township Municipal Utilities Authority as follows:

1. That the contract for road patch material be and are hereby awarded for Item No. 1 to Stavola Asphalt Company subject to all conditions outlined in the attached Notice to Bidders and Specifications; and
2. That the contract for road patch material be and are hereby awarded for Item No. 2 to Trap Rock Industries, Inc. subject to all conditions outlined in the attached Notice to Bidders and Specifications; and
3. That the contracts for road patch material be and are hereby awarded for Item No. 3 to Asphalt Paving Systems, Inc. subject to all conditions outlined in the attached Notice to Bidders and Specifications;

4. That the contract for road patch material be and are hereby awarded for Item Nos. 4, 5 and 6 to Central Jersey Hot Mix Asphalt, LLC subject to all conditions outlined in the attached Notice to Bidders and Specifications; and
5. The Executive Director be and is hereby authorized to return the bid bonds and other security received from unsuccessful bidders within three days after execution of the contracts and to notify all bidders of the award of these contracts.
