BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY

March 26, 2012

**A Resolution Appointing Three Electrical Contractors
for Electrical Work in 2012**

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has solicited bids for the supply of electrical work for 2012 (the "Project"); and

WHEREAS, the bids for the Project have been solicited by the Authority in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*; and

WHEREAS, five bids have been received in response to the bid solicitation, a list and detail of which is attached hereto as Exhibit "A"; and

WHEREAS, the three lowest responsible bidders submitting bids for this Project are from Pro Maintenance Group, Inc., Sun Electrical Construction Corp., and Gary Kubiak & Son Electric, Inc.; and

WHEREAS, the three bids submitted by the apparent lowest responsible bidders have been reviewed by the Authority's Solicitor and found to be acceptable as to form and content; and

WHEREAS, the award of the three contracts for this Project is in conformance with the Authority's budgetary constraints;

NOW, THEREFORE, BE IT RESOLVED this 26th day of March, 2012, by the Brick Township Municipal Utilities Authority as follows:

1. The Authority accepts the recommendations of its Solicitor and awards the contract for electrical work to the three lowest responsible bidders, Pro Maintenance Group, Inc., Sun Electrical Construction Corp., and Gary Kubiak & Son Electric, Inc. The three bids are awarded with the understanding and upon condition that each of the bidders will comply with the current prevailing wage rate in effect for any and all work undertaken on behalf of the Authority.

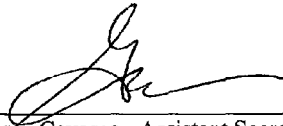
2. The Authority authorizes and directs the Chairman, Secretary and Executive Director to execute any and all necessary documents in order to implement the intent of this Resolution.
