A Resolution of the Brick Township Municipal Utilities
Authority honoring Patrick L. Bottazzi for his 18 years of
service as a Commissioner and Authorizing and Designating the
North End Fishing Station at the Brick Reservoir as the Patrick
L. Bottazzi Fishing Station.

WHEREAS, Patrick L. Bottazzi has been a resident of Brick Township for over 54 years and has been a dedicated public servant to the municipality through service as a Commissioner of the Brick Township Housing Authority from 1972 to 1977, as a member of the Brick Township Planning Board from 1983 to 1987, as a Councilman for the Township of Brick from 1983 to 1989, serving on the Board of Directors of the N.J.T.H.A. from 1987 to 1995 and a Commissioner of the Brick Township Municipal Utilities Authority from 1994 to the present; and

WHEREAS, Patrick L. Bottazzi has been a dedicated civil servant of the Township of Brick and has served his community and his fellow residents by volunteering his time and expertise to many civic organizations including the Brick Elks, the Baywood Yacht Club, the Knights of Columbus, Brick Chamber of Commerce, the New Jersey Restaurant Association, the New Jersey Beverage Association, the North American Hunting Club, the North American Fishing Club, the NYHA, NJHA, PATHA Thoroughbred Horse Associations of New York, New Jersey and Pennsylvania, Brick Township Republican Club and the National Republican Committee; and

WHEREAS, Patrick L. Bottazzi was the owner and operator of the landmark restaurant known as the "Red Lion Inn" in Brick Township for over 35 years; and

WHEREAS, Commissioner Bottazzi has previously received commendations and awards from numerous public and private organizations, from the County of Ocean, the State of New Jersey and he has served as a Grand Marshal of the Columbus Day Parade; and

WHEREAS, Patrick L. Bottazzi, during his tenure on the Board of Commissioners, has played an instrumental role in the forward thinking of the Authority in regards to the long term water supply for the residents of the Township of Brick, which dedication resulted in the development and completion of the Brick Reservoir Project; and

WHEREAS, the Brick Township Municipal Utilities Authority believes it fitting to dedicate the North End Fishing Station located at the Brick Reservoir and to dedicate same as the Patrick L. Bottazzi Fishing Station as a fitting tribute to his dedicated service to the BTMUA, the Township of Brick and the citizens of our community.

NOW THEREFORE BE IT RESOLVED by the Commissioners of the Brick Township Municipal Utilities Authority on this 23rd day of July, 2012 as follows:

- 1. The Authority hereby expresses its deepest thanks and appreciation to Commissioner Patrick L. Bottazzi for his exemplary dedication and generous contributions to the community of Brick Township.
- 2. The Authority hereby designates the North End Fishing Station at the Brick Reservoir as the Patrick L. Bottazzi Fishing Station.
