A Resolution for the Award of a Public Contract to Bricktown Electrical Contracting, LLC in the amount of \$166,638.00 for Natural Gas Powered Generator Replacements – Phase I at the Lanes Mill, Laurel Brook, Laurelton and Pine Meadows Waste Water Pump Stations Contract No. 809001

WHEREAS, on July 30, 2012, The Brick Township Municipal Utilities Authority (“Brick Utilities”) pursuant to Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. duly advertised for bids for Natural Gas Powered Generator Replacements – Phase I for four (4) Wastewater Pump Stations, under Contract No. 809001; and

WHEREAS, nine (9) bids, ranging in price from a low of \$166,638.00 to a high of \$441,292.00 were received pursuant to the advertisement and publicly opened on October 17, 2012 at 2:00 P.M. EST; and

WHEREAS, the three (3) low bids submitted have been reviewed by the Brick Utilities’ Counsel, Jerry J. Dasti, Esq., and the Deputy Executive Director and Director of Engineering/Operations, Stephen T. Specht, P.E.; and

WHEREAS, Stephen T. Specht, P.E., Deputy Executive Director and Director of Engineering/Operations is recommending the award of this Contract to Bricktown Electrical Contracting, LLC, the lowest bidder, in the amount of \$166,638.00; and;


WHEREAS, Frank Planko, Chief Financial Officer, has advised Brick Utilities that sufficient funds for the payment of \$166,638.00 are available within the Authority’s Five Year Capital Plan for Project No. 809001.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK MUNICIPAL UTILITIES AUTHORITY as follows:

1. Brick Utilities awards the contract for this project to Bricktown Electrical Contracting, LLC, in the amount of \$166,638.00; and
2. The Deputy Executive Director is authorized to return the bid bonds and other security received from the unsuccessful bidders within three days after execution of the contract and to notify all bidders of the award of the contract; and
3. The proper officers of Brick Utilities are authorized to execute a contract with Bricktown Electrical Contracting, LLC, 1103 B Industrial Parkway, Brick, N.J. 08724; and
4. Said amount of \$166,638.00 shall be taken from Project No. 809001 for the payment of the obligation provided for herein.
