BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY

**A Resolution Awarding the Contract for Fiber Optic Installation to
Oliver Communications Group, Inc.**

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has solicited bids for a fiber optic installation contract (hereinafter referred to as the "Project"); and

WHEREAS, bids for the contract have been solicited by the Authority in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, six (6) bids were received in response to the bid solicitation, as follows:

1. Oliver Communications Group, Inc. - \$50,680.00;
2. Sun Electric Construction Company - \$161,894.00;
3. Integrated Micro Systems, Inc. - \$53,520.00;
4. Infrasource Telecommunications Services, LLC - \$85,982.00;
5. Kane Communications, LLC - \$70,442.43; and
6. Millennium Communications Group, Inc. - \$60,065.00.

WHEREAS, the bid submitted by Oliver Communications Group, Inc., the apparent lowest responsible bidder, has been reviewed by the Authority's solicitor and its administrative staff, and found to be acceptable as to form and content; and

WHEREAS, the bid submitted by Oliver Communications Group, Inc. is in conformance with the Authority's budgetary constraints.

NOW, THEREFORE, BE IT RESOLVED this 25th day of February, 2013 by the Brick Township Municipal Utilities Authority as follows:

1. The Authority accepts the recommendations of the Authority's solicitor and awards the bid for this project to Oliver Communications Group, Inc. for and in consideration of \$50,680.00.


2. The Authority authorizes and directs the Chairman, Executive Director, and Secretary to execute any and all necessary documents in order to implement the intent of this resolution.
