WHEREAS, the bid submitted by Oliver Communications Group, Inc. is in conformance with the Authority's budgetary constraints.

1. The Authority accepts the recommendations of the Authority's solicitor and awards the bid for this project to Oliver Communications Group, Inc. for and in consideration of \$50,680.00.
