THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY

A Resolution for Award of Bid for Pipe and Appurtenances

WHEREAS, The Brick Township Municipal Utilities Authority (“Brick Utilities”), pursuant to Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. duly advertised for pipe and appurtenances; and

WHEREAS, five bids were received pursuant to the advertisement and publicly opened on April 25, 2013 at 2:00 p.m.; and

WHEREAS, said bids and a recommendation from Chief Financial Officer Frank Planko and Finance Administrative Supervisor Lisa Lau have been reviewed by the Brick Utilities and bid packages having been submitted for the review of Jerry Dasti of Dasti, Murphy, McGuckin, Ulkay, Cherkos & Connors, General Counsel to Brick Utilities; and

WHEREAS, bids were requested for a total of 92 items; and

WHEREAS, it has been determined that since the bid proposal submitted by Raritan Supply was not submitted on the Addendum No. 2 bid form and the signed acknowledgement of Addendum No. 2 was not included with their bid, therefore Raritan Supply’s bid has been rejected; and

WHEREAS, no bids were received for Item Nos. 15, 18, 19, and 91, and that staff will re-bid for those items if and when deemed necessary, and as directed by the Board of Commissioners; and

WHEREAS, Atlantic Plumbing Supply Corporation, did submit a responsive and responsible bid and is low bidder for Item Nos. 7-10, 13, 14, 16, 17, 23, 26-33, 42-45, 47-50, 52, 53, 56 and 60-63; and

WHEREAS, Water Works Supply Co., Inc., did submit a responsive and responsible bid and is low bidder for Item Nos. 34, 36, 38, 39, 51, 54 and 58; and

WHEREAS, Cutter Drill & Machine, Inc., did submit a responsive and responsible bid and is low bidder for Items Nos. 11, 20, 35, 37, 64-90 and 92; and

WHEREAS, HD Supply Waterworks, Ltd. did submit a responsive and responsible bid and is low bidder for Items Nos. 1-6, 12, 21, 22, 24, 25, 40, 41, 46, 55, 57 and 59; and

WHEREAS, Cutter Drill & Machine, Inc., took an exception to Item No. 20 that is not acceptable to the Authority; and

WHEREAS, as a result of the exception taken by Cutter Drill & Machine, Inc., the Authority will award the bid for Item No. 20 to the next lowest bidder HD Waterworks, Ltd.; and

WHEREAS, the term of the Contract with Atlantic Plumbing Supply Corporation, Cutter Drill and Machine, Inc., HD Supply Waterworks, Ltd., and Water Works Supply Co., Inc. shall be for one year from the date of award; and

WHEREAS, Frank Planko, Chief Financial Officer, has advised the Authority that various operating and capital accounts, exact amounts not currently known, will be impacted by purchases associated with this resolution.

NOW THEREFORE, BE IT RESOLVED by the Commissioners of the Brick Township Municipal Utilities Authority as follows:

1. That the Contract for the Pipe and Appurtenances Item Nos. 7-10, 13, 14, 16, 17, 23, 26-33, 42-45, 47-50, 52, 53, 56 and 60-63 for a total bid amount of \$18,060.06 is awarded to Atlantic Plumbing Supply Corporation in accordance with the attached Bid Award Sheet; and
2. That the Contract for the Pipe and Appurtenances Items Nos. 11, 35, 37, 64-90 and 92 for a total bid amount of \$33,505.88 is awarded to Cutter Drill and Machine, Inc. in accordance with the attached Bid Award Sheet; and
3. That the Contract for the Pipe and Items Nos. 1-6, 12, 20, 21, 22, 24, 25, 40, 41, 46, 55, 57 and 59 for a total bid amount of \$3,370.43 is awarded to HD Supply Waterworks, Ltd. In accordance with the attached Bid Award Sheet; and
4. That the Contract for the Pipe and Appurtenances Item Nos. 34, 36, 38, 39, 51, 54 and 58 for a total bid amount of \$3,652.25 is awarded to Water Works Supply Co., Inc. in accordance with the attached Bid Award Sheet; and
5. The Executive Director be and is hereby authorized to notify all bidders of the award of these contracts.
