**THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**A Resolution for Award of Bid for Pipe and Appurtenances,  
Specifically Items No. 2 and 3 to the sole bidder,  
Atlantic Plumbing Supply Corp.**

**WHEREAS**, The Brick Township Municipal Utilities Authority ("Brick Utilities"), pursuant to Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. duly advertised for pipe and appurtenances, specifically Items No. 2 and 3; and

**WHEREAS**, one (1) bid was received pursuant to the advertisement and publicly opened on April 25, 2013 at 2:00 p.m.;

**WHEREAS**, said bid and a recommendation from Chief Financial officer Frank Planko and Finance Administrative Supervisor Lisa Lau have been reviewed by the Brick Utilities and the bid package having been submitted for the review of Jerry Dasti, Esquire of Dasti, Murphy, McGuckin, Ulaky, Koutsouris and Connors, General Counsel to Brick Utilities; and;

**WHEREAS**, Atlantic Plumbing Supply Corp. did submit a responsive and responsible bid and is low bidder for Items No. 2 and 3 (\$1,190.00 total for Item No. 2, and \$1,190.00 total for Item No. 3) for a total bid amount of \$2,380.00; and

**WHEREAS**, the term of the Contract with Atlantic Plumbing Supply Corp. shall be for one (1) year from the date of the award; and


**WHEREAS**, Frank Planko, Chief Financial Officer, has advised the Authority that various operating and capital accounts, exact amounts not currently known, will be impacted by purchases associated with this Resolution.

1. That the Contract for the Pipe and Appurtenance Item Nos. 2 and 3 (\$1,190.00 total for Item No. 2, and \$1,190.00 total for Item No. 3) for a total bid amount of \$2,380.00.
2. The Executive Director be and is hereby authorized to notify all bidders of the award of these contracts.
