A Resolution Appointing the professional engineering firms of CME Associates, PS&S, French & Parrello, Associates, PA, and Adams, Rehmann & Heggan Associates, Inc., as the Alternate Consulting Engineers to The Brick Township Municipal Utilities Authority for the term February 1, 2014 through January 31, 2015.

WHEREAS, there exists a need for alternate consulting engineering services by the Brick Township Municipal Utilities Authority; and

WHERAS, in accordance with <u>N.J.S.A</u> 19:44A-20-5 <u>et. seq.</u> (New Jersey Pay to Play Law), the Authority advertised in its official papers a Notice of Solicitation for RFQ's, and

WHEREAS, on January 27, 2014, the duly advertised date for receipt of RFQ's, the Authority opened and reviewed all Qualifications from interested parties; and

WHEREAS, at the Annual Reorganization Meeting of the Authority on February 3, 2014, the Board of Commissioners did duly accept the appointment of firms to fill these positions, and

WHEREAS, N.J.S.A. 40A:11-5(1)(a)(i) permits the award of contracts for such professional services without public bidding;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY, as follows:

- CME Associates, 1460 Route 9 South, Howell, NJ, 07731, PS&S 1433 State Route 34, Suite 101, Wall, NJ 07719, French & Parrello Associates, PA, 1800 Route 34, Suite 101, Wall, New Jersey, 07719, and Adams, Rehmann & Heggan Assoc., Inc., 850 South Whitehorse Pike, Hammonton, NJ 08037 are hereby appointed as the Alternate Consulting Engineers to the Brick Township Municipal Utilities Authority from February 1, 2014 until January 31, 2015 or until the first meeting of the Authority after such date.
- The Authority Chairman and Secretary are hereby authorized and directed to execute an Agreement for Professional Services with said firm, with a fee schedule in accordance with the RFQ for professionals/consultants.
- 3. This contract is awarded without competitive bidding as a "professional service" in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts Law.
- 4. The offices of CME Associates, PS&S, French & Parrello Associates, PA. and Adams, Rehmann & Heggan Assoc, Inc., shall maintain at all times during the term of this employment adequate Professional Liability Insurance including, but not limited to, an Errors and Omissions Policy in an amount not less than \$1 million.
- The Executive Director shall cause notice of award of said appointment to be published once in the official newspaper of the Authority.
