WHEREAS, the bid submitted by Metropolitan Truck Sales, Inc., the apparent lowest responsible bidder, has been reviewed by the Authority's solicitor and its administrative staff, and found to contain no material defects mandating rejection; and

WHEREAS, Brick Utilities Chief Financial Officer, Frank Planko, has advised that sufficient funds for the payment of \$219,000.00 are available to satisfy the Authority's payment obligation.
