**A Resolution Authorizing the Change Order No. 2 in the  
Contract between Brick Utilities and Layne Christensen Co., Inc.  
for a Decrease in the Contract Amount by \$6,500.00 for Contract No. 708003-  
New Aquifer Storage & Recovery (ASR) Well No. 15A**

**WHEREAS**, The Brick Township Municipal Utilities Authority (the "Brick Utilities") did enter into a contract with Layne Christensen Co., Inc. for work associated with the construction of a new Aquifer Storage & Recovery Well No. 15A (formerly called ASR Well No. 15) Contract No. 708003, which contract was authorized by Resolution No. 64-10; and

**WHEREAS**, said changes are shown on a document entitled, Change Order No. 2 dated November 24, 2014; and

**WHEREAS**, said change order provides for a decrease of \$6,500.00 from the originally revised contract amount of \$3,970,020.00 resulting in the revised contract amount of \$3,963,520; and

**WHEREAS**, Brick Utilities and Layne Christensen Co., Inc., Inc. have agreed to such changes; and

**WHEREAS**, said decrease amount is fair and reasonable and could not have been foreseen when the contract was advertised and awarded; and

**WHEREAS**, Brick Utilities' Deputy Executive Director and Director of Engineering/Operations, Stephen T. Specht, P.E., has reviewed this change order and is recommending that it be approved; and

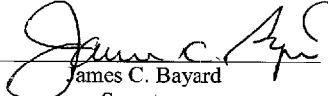
**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF BRICK**
