NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY, as follows:

- 1. Larsen & Fallon, LLP, 1390 Route 36, Suite 102, Hazlet, NJ 07730 is hereby appointed as Auditor to The Brick Township Municipal Utilities Authority from February 1, 2014 until January 31, 2015, or until the first meeting of the Authority after such date.
- 2. The Authority Chairman and Secretary are hereby authorized and directed to execute an Agreement for Professional Services with said firm, with a fee schedule in accordance with the RFQ for professionals/consultants, and which agreement is made a part hereof.
- 3. The offices of Fallon & Larsen, LLP, shall maintain at all times during the term of this employment adequate Professional Liability Insurance including, but not limited to, an Errors and Omissions Policy in an amount not less than \$1 million.
- 3. This contract is awarded without competitive bidding as a "professional service" in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts Law.
- 4. The Executive Director shall cause notice of award of said appointment to be published one time in the designated official newspaper of the Authority.
