A Resolution for the award of Contract for Electrical Work

WHEREAS, the Brick Township Municipal Utilities Authority (Brick Utilities), pursuant to Local Contracts Law N.J.S.A. 40A:11-1 et seq., duly advertised for bids for the supply of electrical work on an annual basis (hereinafter referred to as the "contract"); and

WHEREAS, six (6) bids were received pursuant to the advertisement and publicly opened on March 12, 2014; and

WHEREAS, said bids packages and a recommendation from Lisa Lau have been submitted for the review of Nicholas C. Montenegro of Montenegro, Thompson, Montenegro & Genz, General Counsel to the Brick Utilities; and

WHEREAS, it has been determined that the three lowest responsible and responsive bids received in response to the bid solicitation are as follows:

WHEREAS, the term of the Contract for supply of Electrical Work with the above noted vendors shall be from May 1, 2014 through April 30, 2015; and


WHEREAS, Frank Planko, Chief Financial Officer, has advised that the Brick Utilities has budgeted funds in various Operating and Capital Accounts in the 2014/2015 Budget.

NOW, THEREFORE, BE IT RESOLVED this 24th day of March, 2014, by the Brick Township Municipal Utilities Authority, as follows:

1. The Authority accepts and approves the bids submitted by the above referenced bidders, at the rates set forth hereinabove, with the understanding that all rates shall be at least the minimum prevailing wage rate as determined for the County of Ocean and County of Monmouth.
2. That the contracts for Electrical Work be, and hereby are, awarded subject to all conditions outlined in the attached Notice to Bidders and Specifications.
3. That the Executive Director be and hereby is authorized to return the bid bonds and other securities received from the unsuccessful bidders within the three days after execution of the contracts and to notify all bidders of the award of the contract.
