A Resolution for Award of Bid for Pipe and Appurtenances

WHEREAS, The Brick Township Municipal Utilities Authority ("Brick Utilities"), pursuant to Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. duly advertised for pipe and appurtenances; and

WHEREAS, three bids were received pursuant to the advertisement and publicly opened on April 16, 2014 at 9:00 a.m.; and

WHEREAS, said bids and a recommendation from Qualified Purchasing Agent Robert W. Bowers have been reviewed by the Brick Utilities and bid packages having been submitted for the review of Nicholas C. Montenegro of Montenegro, Thompson, Montenegro & Genz, General Counsel to Brick Utilities; and

WHEREAS, bids were requested for a total of 100 items; and

WHEREAS, no bids were received for Item No. 90, and that staff will re-bid for those items if and when deemed necessary, and as directed by the Board of Commissioners; and

WHEREAS, Atlantic Plumbing Supply Corporation, did submit a responsive and responsible bid and is low bidder for Item Nos. 4, 6, 8, 10-11, 18-21, 23, 37-43, 45-46, 48, 51-59, 61-62, 65-67; and

WHEREAS, Cutter Drill & Machine, Inc. did submit a responsive and responsible bid and is low bidder for Item Nos. 24, 36, 44, 49, 60, 68-89, 91-100; and

WHEREAS, HD Supply Waterworks, Ltd. did submit a responsive and responsible bid and is low bidder for Item Nos. 1-3, 5, 7,9, 12-17, 22, 25-35, 47, 50, 63-64,

WHEREAS, the term of the Contract with Atlantic Plumbing Supply corporation, Cutter Drill and Machine, Inc. and HD Supply Waterworks, Ltd. shall be for one year from the date of award; and

WHEREAS, Frank Planko, Chief Financial Officer, has advised the Authority that various operating and capital accounts, exact amounts not currently known, will be impacted by purchases associated with this resolution.


NOW THEREFORE, BE IT RESOLVED by the Commissioners of the Brick Township Municipal Utilities Authority as follows:

1. That the Contract for the Pipe and Appurtenance Item Nos. 4, 6, 8, 10-11, 18-21, 23, 37-43, 45-46, 48, 51-59, 61-62, and 65-67 for a total bid amount of \$15,582.55 is awarded to Atlantic Plumbing Supply Corporation in accordance with the attached Bid Award Sheet; and

2. That the Contract for the Pipe and Appurtenances Item Nos. 24, 36, 44, 49, 60, 68-89, and 91-100 for a bid amount of \$11,323.29 is awarded to Cutter Drill & Machine, Inc. in accordance with the attached Bid Award Sheet; and
3. That the Contract for the Pipe and Appurtenances Item Nos. 1-3, 5, 7, 9, 12-17, 22, 25-35, 47, 50, and 63-64 for a total bid amount of \$9,441.55 is awarded to HD Supply Waterworks, Ltd. In accordance with the attached Bid Award Sheet; and
4. The Executive Director be and is hereby authorized to notify all bidders of the award of these contracts.
