WHEREAS, the bid submitted by Harter Equipment, Inc., the apparent lowest responsible bidder, has been reviewed by the Authority's staff, and found to be acceptable as to form and content; and

WHEREAS, Brick Utilities Chief Financial Officer, Frank Planko, has advised that sufficient funds for the payment of \$26,575.00 are accounted in the Authority's Capital Plan within Project No. 914009.
