

**RESOLUTION NO. 90 -14**

**BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**August 25, 2014**

**A Resolution Authorizing and Approving  
a Shared Service Agreement with the Township of Brick  
for a Notification/Reverse 911 System**

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority"), has entered into and confirms a Shared Service Agreement with the Township of Brick (hereinafter referred to as the "Township") for sharing of a Notification/Reverse 911 System; and

**WHEREAS**, the Township purchases a yearly agreement with Cassidian Communications for the use of their Notification/Reverse 911 System; and

**WHEREAS**, the Township and the Authority wish to avoid duplication of costs and share the system between both agencies; and

**WHEREAS**, the Authority is in need of such services which can be provided by the Township, utilizing the Township's Notification/Reverse 911 System; and

**WHEREAS**, the Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq., authorizes the Authority to enter into a contract for the provision of certain governmental services with the Township of Brick; and

**WHEREAS**, N.J.S.A. 40A:65-6 requires that such a contract be authorized by resolution; and

**WHEREAS**, it is the desire of the Authority to authorize the execution of a Shared Service Agreement with the Township of Brick for the use of a Notification/Reverse 911 system.

**NOW, THEREFORE, BE IT RESOLVED** this 25<sup>th</sup> day of August 2014, by the Board of Commissioners of the Brick Township Municipal Utilities Authority, County of Ocean, State of New Jersey, as follows:

1. That the Authority through the Board of Commissioners, does hereby authorize and confirm the execution of a Shared Service Agreement with the Township of Brick for the use of a Notification/Reverse 911 system.

2. That the Authority authorizes and directs the Executive Director to execute and confirm the Shared Service Agreement and any other documents necessary to effectuate the terms of this Resolution.


3. A copy of the Agreement referenced herein and made a part hereof is kept on file and made available for public inspection at the Authority's business office during normal business hours.

4. A copy of this Resolution shall be provided to the following:
