A Resolution Authorizing the Final Quantities Change Order/Change Order No. 4 in the Contract between the Brick Township Municipal Utilities Authority and Stacey Contracting, Inc. for a Decrease in the Contract Amount of \$30,480.35 for Contract No. 897087K Sanitary Sewer Replacement – Phase VI N. J. Environmental Infrastructure Financing Program, Project No. S340448-06, Contract 3B

WHEREAS, the Brick Township Municipal Utilities Authority (The Authority) did enter into a contract with Stacey Contracting, Inc. ('Stacey Contracting') for the associated work with the Sanitary Sewer Replacement – Phase VI; Contract No. 897087K which contract was authorized by Resolution No. 03-10; and

WHEREAS, there were three previous Change Order Nos. 1, 2 and 3 which increased the contract amount and were authorized by Resolution No. 67-10, Resolution 35-11 and Resolution No. 81-11 increasing the contract to the amount totaling \$837,126.61; and

WHEREAS, the Sanitary Sewer Replacement – Phase VI is a unit price contract resulting in the need for a final quantities change order; and

WHEREAS, said changes are shown on the document entitled, Final Quantities Change Order/Change Order No. 4; and

WHEREAS, said change order provides for a decrease of \$30,480.35 of the revised contract amount of \$837,126.61 resulting in a final contract amount of \$806,646,26; and

WHEREAS, the Authority and Stacey Contracting have agreed to such changes; and

WHEREAS, said decreased amount is fair and reasonable and could not have been foreseen when the contract was advertised and awarded; and

WHEREAS, the Sanitary Sewer Replacement – Phase VI Contract is being financed with the assistance from the New Jersey Environmental Infrastructure Financing Program ("NJEIFP"); and

WHEREAS, the NJEIFP must review and approve the Final Quantities Change Order; and

WHEREAS, the Authority's Deputy Executive Director & Director of Engineering/Operations, Stephen T. Specht, P.E. has reviewed this change order and is recommending that it be approved; and

NOW, THEREFORE, BE IT RESOLVED BY the Commissioners of the Brick Township Municipal Utilities Authority as follows:

- The contract between the Authority and Stacey Contracting is amended and the change order entitled Final Quantities Change Order/Change Order No. 4 dated July 22, 2014 may be executed by the officers and employees of the Authority upon execution of such change order by the appropriate officials for Stacey Contacting and upon the approval of the NJEIFP; and
