A Resolution for the Award of Public Contract to Quad Construction Company in the Amount of \$2,716,000 for Contract No. 812003, Wastewater Pumping Stations Rehabilitation

WHEREAS, The Brick Township Municipal Utilities Authority ("Brick Utilities") owns and operates 26 sewerage pumping stations within the sewer collection system; and

WHEREAS, due to the devastation caused by Super Storm Sandy on October 29 and 30, 2012, eight (8) of those stations suffered severe flooding; and

WHEREAS, in order to minimize any future impact to these stations, Brick Utilities is recommending that the existing below grade pumps, motors and compressors along with the associated motor starters, controls, disconnect switches, and wiring be eliminated and replaced with submersible pumps with the motor starters, controls and disconnect switches located in the generator building and/or above the current high water level caused by Super Storm Sandy; and

WHEREAS, Brick Utilities pursuant to Local Public Contracts Law N.J.S.A. 40A: 11-1 et seq. duly advertised for bids for Contract No. 812003; and

WHEREAS, seven (7) bids, with prices of a low \$2,716,000 and a high of \$4,059,985 were received pursuant to the advertisement and publicly opened on September 11, 2014 at 2:00 P.M. EST; and

WHEREAS, the three (3) lowest bids submitted have been reviewed by Brick Utilities' Counsel, and the Deputy Executive Director and Director of Engineering/Operations, Stephen T. Specht, P.E., and

WHEREAS, Stephen T. Specht, P.E., Deputy Executive Director and Director of Engineering and Operations is recommending the award of this Contract to Quad Construction Company the low bidder in the amount of \$2,716,000; and

WHEREAS, Quad Construction Company submitted the lowest responsive and responsible bid of \$2,716,000; and

WHEREAS, Frank Planko, Chief Financial Officer, has advised Brick Utilities that sufficient funds for the payment of \$2,716,000 are accounted in Brick Utilities' Capital Plan within Project No. 812003.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY as follows:

- Brick Utilities awards the contract for this project to Quad Construction Company for \$2,716,000; and
- The Executive Director is authorized to return the bid bonds and other security received from the unsuccessful bidders within three days after execution of the contract and to notify all bidders of the award of the contract; and
- The proper officers of Brick Utilities are authorized to execute a contract with Quad Construction Company, 732 Eayrestown Road, Lumberton, NJ 08048; and
- Said amount of \$2,716,000 shall be taken from Project No. 812003 for the payment of the obligation provided for herein.
