**A Resolution for Approving and Authorizing Award of Contract to Pullman SST, Inc. in the amount of \$84,500.00 for the Contraction Joint Repairs in the Reservoir Conduit Access Chamber Project (Contract No. 712004)**

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has solicited bids for the Contraction Joint Repairs in the Reservoir Conduit Access Chamber Project (Contract No. 712004) (the "Contraction Joint Repairs Project"); and

**WHEREAS**, bids for the Contract have been solicited by the Authority in conformance with the provisions of the New Jersey Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

**WHEREAS**, bids were submitted in response to the bid solicitation, as follows:

1. Pullman SST, Inc. \$84,500.00

**WHEREAS**, submitted bid has been reviewed by the Authority's Consulting Engineer for the Contract, Michael Schappert, P.E. of French & Parrello Associates Engineers, the Authority's Director of Engineering/Operations Stephen T. Specht, P.E., and the Authority's Counsel, Nicholas C. Montenegro, Esquire; and

**WHEREAS**, the Authority's Consulting Engineer for the Contract, Michael Schappert, P.E. and the Authority's Director of Engineering/Operations Stephen T. Specht, P.E. are recommending the award of this Contract to Pullman SST, Inc., the lowest bidder, in the amount of \$84,500.00; and

**WHEREAS**, Brick Utilities' Chief Financial Officer, Frank Planko, has advised Brick Utilities that sufficient funds for the payment of \$84,500.00 do exist for Project No. 712004; and

**NOW, THEREFORE, BE IT RESOLVED** this 24<sup>th</sup> day of August, 2015, by the Brick Township Municipal Utilities Authority as follows:


1. The Contraction Joint Repairs in the Reservoir Conduit Access Chamber Project (Contract No. 712004) is hereby awarded to the low bidder, Pullman SST, Inc., in the amount of \$84,500.00 subject to all conditions outlined in the Notice to Bidders, Specifications and Contract documents; and
2. The Authority's Consulting Engineer for the Contract, Michael Schappert, P.E., has recommended to the Authority that Pullman SST, Inc. as the low bidder be awarded the Contract; and
3. The Authority's Director of Engineering/Operations for the Contract, Stephen T. Specht, is authorized to return the bid bonds and other security received from any unsuccessful bidders within three (3) days after the execution of the contract and to notify all bidders of the award of the contract; and
4. The Authority's Chairman and Secretary are hereby authorized to execute a contract with Pullman SST, Inc., 2227 High Hill Road, Swedesboro, NJ 08085.
