- The Authority accepts the recommendations of its Solicitor and other professionals with regard to the S.J.B. litigation.
- 2. The Authority hereby authorizes its Solicitor to execute any and all documents necessary to effectuate the settlement with S.J.B. subject to the terms of the General Release of Claims and Settlement Agreement drafted by the Authority's Solicitor.
- 3. The Authority authorizes and directs the Chairman, Executive Director, Chief Financial Officer and Secretary to execute any and all necessary documents in order to implement the intent of this Resolution.
