- DeCotiis, Fitzpatrick & Cole, 500 Frank W. Burr Blvd., Teaneck, NJ 07666, are hereby appointed as Bond Counsel to The Brick Township Municipal Utilities Authority from February 1, 2016 until January 31, 2017, or until the first meeting of the Authority after such date.
- The Authority Chairman and Secretary are hereby authorized and directed to execute the attached agreements for professional services with said firm which includes a fee on an hourly basis at the rate of \$175.00 per hour, which agreements are made a part hereof.
 - 3. The Authority Chairman and Secretary are hereby authorized and directed to execute an Agreement for professional services with said attorney.
 - 4. The offices of *DeCotiis, Fitzpatrick & Cole* shall maintain at all times during the term of this employment adequate Professional Liability Insurance including, but not limited to, an Errors and Omissions Policy in an amount as indicated in the RFQ.
 - 5. This contract is awarded without competitive bidding as a "professional service" in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts Law.
 - The Executive Director shall cause notice of award of said appointment to be published once in the Asbury Park Press.
