

**RESOLUTION NO. 14-16**

**THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

February 1, 2016

*A Resolution Appointing the professional engineering firms of CME Associates, PS&S, Adams, Rehmann & Heggan Associates, Inc., H2M Architects + Engineers, Suburban Consulting Engineers, Inc., D.W. Smith Associates, LLC, and Boswell Engineering as the Alternate Consulting Engineers to The Brick Township Municipal Utilities Authority for the term February 1, 2016 through January 31, 2017.*

WHEREAS, there exists a need for alternate consulting engineering services by the Brick Township Municipal Utilities Authority; and

WHEREAS, in accordance with N.J.S.A. 19:44A-20-5 et. seq. (New Jersey Pay to Play Law), the Authority advertised in its official papers a Notice of Solicitation for RFQ's, and

WHEREAS, on January 22, 2016, the duly advertised date for receipt of RFQ's, the Authority opened and reviewed all Qualifications from interested parties on January 22, 2016; and

WHEREAS, at the Annual Reorganization Meeting of the Authority on February 1, 2016, the Board of Commissioners did duly accept the appointment of firms to fill these positions, and

WHEREAS, N.J.S.A. 40A:11-5(1)(a)(i) permits the award of contracts for such professional services without public bidding;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY, as follows:

1. **CME Associates**, 1460 Route 9 South, Howell, NJ, 07731, **PS&S** 1433 State Route 34, Suite 101, Wall, NJ 07719, **DW Smith Associates, LLC**, 1450 State Route 34, Wall, NJ 07753, **Adams, Rehmann & Heggan Assoc., Inc.**, 850 South Whitehorse Pike, Hammonton, NJ 08037, **H2M Architects + Engineers**, 2380 Route 9 South, Building C, Suite 1, Howell, NJ 07731, and **Suburban Consulting Engineers, Inc.**, 1704 Maxwell Drive, Suite 304, Wall, NJ 07719 and **Boswell Engineering**, 330 Phillips Avenue, South Hackensack, NJ 07606-1722 are hereby appointed as the Alternate Consulting Engineers to the Brick Township Municipal Utilities Authority from February 1, 2016 until January 31, 2017 or until the first meeting of the Authority after such date.
2. The Authority Chairman and Secretary are hereby authorized and directed to execute an Agreement for Professional Services with said firm, with a fee schedule in accordance with the RFQ for professionals/consultants.
3. This contract is awarded without competitive bidding as a "professional service" in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts Law.
4. The offices of CME Associates, PS&S, DW Smith Associates, LLC, Boswell Engineering, Adams, Rehmann & Heggan Assoc, Inc., H2M Architects + Engineers, Suburban Consulting Engineers, Inc., shall maintain at all times during the term of this employment adequate Professional Liability Insurance including, but not limited to, an Errors and Omissions Policy in an amount in accordance with the RFQ for professionals/consultants.
4. The Executive Director shall cause notice of award of said appointment to be published once in the official newspaper of the Authority.
