

**RESOLUTION NO. 33-16**

**BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**March 28, 2016**

**A Resolution for Approving and Authorizing the Award of a Contract for Exterior Concrete Services to J & N Mason Contractors, LLC. in the amount of \$39,788.00**

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") awarded via Resolution No. 71-15 a contract for the Fabrication and Installation of a Fleet Storage Building on the premises of the Authority;

**WHEREAS**, the superstructure for the Fleet and Equipment Storage Building is essentially complete and the installation of exterior concrete aprons, sidewalks and pads is now required; and

**WHEREAS**, the Authority solicited proposals for the installation of such exterior concrete services; and

**WHEREAS**, three (3) service providers submitted quotes as follows:

1.	J & N Mason Contractors, LLC	\$39,788.00
2.	Jamali Developers, LLC	\$45,621.00
3.	A Team Concrete, Inc.	\$74,572.00

**WHEREAS**, the bid submitted by J & N Mason Contractors, LLC in the amount of \$39,788.00 met all of the requirements of the project and was in compliance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; including the provisions for the procurement of contracts below the bid threshold by a Qualified Purchasing Agent; and

**WHEREAS**, Stephen T. Specht, P.E., Deputy Executive Director and Director of Engineering and Operations is recommending the award of this contract to J & N Mason Contractors, LLC, the low bidder in the amount of \$39,788.00.

**WHEREAS**, the Authority's Chief Financial Officer, Frank Planko, has advised that sufficient funds for the payment of \$39,788.00 are available to satisfy the Authority's payment obligation.

**NOW, THEREFORE, BE IT RESOLVED** this 28<sup>th</sup> day of March, 2016 by the Brick Township Municipal Utilities Authority as follows:

1. The Exterior Concrete Services contract is hereby awarded to J & N Mason Contractors, LLC in the amount of \$39,788.00.
2. The Authority authorizes and directs the Chairman and Secretary to execute any and all necessary documents in order to implement the intent of this Resolution subsequent to the execution of same by J & N Mason Contractors, LLC.
