**THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**May 23, 2016**

**A Resolution for Award of Bid for Water and Sewer Pipe and Appurtenances**

**WHEREAS**, the Brick Township Municipal Utilities Authority ("Brick Utilities"), pursuant to Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. duly advertised for bid for water and sewer pipe and appurtenances; and

**WHEREAS**, three bids were received pursuant to the advertisement and publicly opened on May 10, 2016 at 10:00 a.m.; and

**WHEREAS**, said bids and a recommendation from Qualified Purchasing Agent Robert W. Bowers have been reviewed by the Brick Utilities and bid packages having been submitted for the review of Ben A. Montenegro of Montenegro, Thompson, Montenegro & Genz, General Counsel to Brick Utilities; and

**WHEREAS**, bids were requested for a total of 84 items; and

**WHEREAS**, no bids were received for Item Nos. 58, 67 and 69 and staff will go out for quotes on these items, if and when deemed necessary; and

**WHEREAS**, Atlantic Plumbing Supply Corporation, did submit a responsive and responsible bid and is low bidder for Item Nos. 3, 12, 16-19, 21, 24-25, 28-29, 32-37, 39, 44 and 47-50; and

**WHEREAS**, Cutter Drill & Machine, Inc. did submit a responsive and responsible bid and is low bidder for Item Nos. 9, 51-57, 59-66, 68 and 70-84; and

**WHEREAS**, HD Supply Waterworks, Ltd. did submit a responsive and responsible bid and is low bidder for Item Nos. 1-2, 4-8, 10-11, 13-15, 20, 22-23, 26-27, 30-31, 38, 40-43 and 45-46; and

**WHEREAS**, the term of the Contract with Atlantic Plumbing Supply Corporation, Cutter Drill and Machine, Inc. and HD Supply Waterworks, Ltd. shall be for one year from the date of award; and


**WHEREAS**, Frank Planko, Chief Financial Officer, has advised the Authority that various operating and capital accounts, exact amounts not currently known, will be impacted by purchases associated with this resolution.

**NOW, THEREFORE, BE IT RESOLVED** by the Commissioners of the Brick Township Municipal Utilities Authority as follows:

1. That the Contract for the Pipe and Appurtenance Item Nos. 3, 12, 16-19, 21, 24-25, 28-29, 32-37, 39, 44 and 47-50 for a total bid amount of \$10,572.96 is awarded to Atlantic Plumbing Supply Corporation in accordance with the attached Bid Award Sheet; and
2. That the Contract for the Pipe and Appurtenance Item Nos. 9, 51-57, 59-66, 68 and 70-84 for a total bid amount of \$11,728.00 is awarded to Cutter Drill & Machine, Inc. in accordance with the attached Bid Award Sheet; and
3. That the Contract for the Pipe and Appurtenance Item Nos. 1-2, 4-8, 10-11, 13-15, 20, 22-23, 26-27, 30-31, 38, 40-43 and 45-46 for a total bid amount of \$19,212.90 is awarded to HD Supply Waterworks, Ltd. in accordance with the attached Bid Award Sheet; and
4. The Qualified Purchasing Agent be and is hereby authorized to notify all bidders of the award of these contracts.
