

**RESOLUTION NO. 71-16**

**THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**  
September 26, 2016

**A Resolution for Approving and Authorizing the Award of a Public Contract to Pillari Brothers Construction Corp. in the amount of \$364,212.20 for the Parkway Service Territory Interconnections on Cherry Lane and Redbud Lane, the East Granada Drive Water Main Extension and the Winding River Lane and Oak Knoll Drive Water Main Upgrades; Contract No. 715006**

**WHEREAS**, on August 1, 2016 The Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., advertised for bids for the Parkway Service Territory Interconnections on Cherry Lane and Redbud Lane, the East Granada Drive Water Main Extension and the Winding River Lane and Oak Knoll Drive Water Main Upgrades under Contract No. 715006; and

**WHEREAS**, three bids ranging in price from a corrected low of \$364,212.20 to a high of \$505,744.81 were received pursuant to the advertisement and publicly opened on September 1, 2016 at 11:00 A.M.; and

**WHEREAS**, submitted bids have been reviewed by the Authority's consulting engineer for the Contract, Susan S. Brasefield, P.E., P.P., C.M.E., Maser Consulting, P.A. the Authority's Deputy Executive Director and Director of Engineering/Operations, Stephen T. Specht, P.E. and the Authority's Counsel, Ben A. Montenegro, Esq.; and

**WHEREAS**, the Authority's Consulting Engineer for the Contract, Susan S. Brasefield, P.E., P.P., C.M.E., Maser Consulting, P.A. noted no irregularities, other than the corrected bid amount for Pillari Brothers Construction Corp., with the bid received from Pillari Brothers Construction Corp., Perna Finnegan, Inc. or Mathis Construction Co., Inc. as part her review of all of the bids; and

**WHEREAS**, Brick the Authority's Consulting Engineer for the Contract, Susan S. Brasefield, P.E., P.P., C.M.E., Maser Consulting, P.A. and the Authority's Deputy Executive Director and Director of Engineering/Operations, Stephen T. Specht, P.E. are recommending the award of this Contract to Pillari Brothers Construction Corp, the lowest bidder, in the amount of \$364,212.20; and

**WHEREAS**, the Authority's Executive Director, Chris A. Theodos, P.E., P.P., C.M.E., C.P.W.M., C.F.M., has advised the Authority that sufficient funds for the payment of \$364,212.20 are available in Capital Project No. 715006 – Parkway Service Territory Interconnections on Cherry Lane and Redbud Lane, the East Granada Drive Water Main Extension and the Winding River Lane and Oak Knoll Drive Water Main Upgrades of the FY 2016/2017 Budget Book's 5 Year Estimated Capital Outlook.


**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY** as follows:

1. The Parkway Service Territory Interconnections on Cherry Lane and Redbud Lane, the East Granada Drive Water Main Extension and the Winding River Lane and Oak Knoll Drive Water Main Upgrades; Contract No. 715006 is hereby awarded to the low bidder, Pillari Brothers Construction Corp. in the amount of \$364,212.20 subject to all conditions outlined in the Notice to Bidders, Specifications and Contract Documents; and
2. The Authority's Consulting Engineer for the Contract, Susan S. Brasefield, P.E., P.P., C.M.E., Maser Consulting, P.A. has recommended to the Authority that Pillari Brothers Construction Corp. as the low bidder be awarded the Contract; and
3. The Authority's Consulting Engineer for the Contract, Susan S. Brasefield, P.E., P.P., C.M.E., Maser Consulting, P.A. is authorized to return the bid bonds and other security received from the unsuccessful bidder within three (3) days after the execution of the contract and to notify all bidders of the award of the contract; and
4. The Authority's Chairman and Secretary are hereby authorized to execute a contract with Pillari Brothers Construction Corp., 65 Squankum Yellowbrook Road, Farmingdale, New Jersey, 07727 for this project subsequent to the execution of same by Pillari Brothers Construction Corp.; and
5. Said amount of \$364,212.20 shall be taken from Capital Project No. 715006 – Parkway Service Territory Interconnections on Cherry Lane and Redbud Lane, the East Granada Drive Water Main Extension and the Winding River Lane and Oak Knoll Drive Water Main Upgrades of the FY 2016/2017 Budget Book's 5 Year Estimated Capital Outlook; and
