**THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**March 30, 2017**

**A Resolution for the Award of Bid for Road Patch Materials**

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as “Brick Utilities”), pursuant to Local Contracts Law N.J.S.A. 40A:11-1 et. seq., duly advertised for bids for Road Patching Materials; and

**WHEREAS**, six (6) bids were received pursuant to the advertisement and publicly opened on March 1, 2017; and

**WHEREAS**, said bid packages and a recommendation from Robert Bowers, Q.P.A., have been submitted for the review of Ben A. Montenegro of Montenegro, Thompson, Montenegro & Genz, General Counsel to the Brick Utilities; and

**WHEREAS**, it has been determined that the lowest responsible and responsive bidders for the seven (7) items are as follows and therefore should be awarded:

3. That the Qualified Purchasing Agent be and hereby is authorized to return the bid bonds and other securities received from the unsuccessful bidders within the three (3) days after execution of the contracts and to notify all bidders of the award of the contract.


