**THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**April 27, 2017**

**A Resolution for the Award of Contract for Electrical Work**

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as “Brick Utilities”), pursuant to Local Contracts Law N.J.S.A. 40A:11-1 et. seq., duly advertised for bids for the supply of electrical work on an annual basis (hereinafter referred to as the “Contract”); and

**WHEREAS**, three (3) bids were received pursuant to the advertisement and publicly opened on April 5, 2017 from Starlite Electric, LLC; Multi-Temp Mechanical Inc.; and Ascend Construction Management, Inc.; and

**WHEREAS**, said bid packages and a recommendation from Robert Bowers, Qualified Purchasing Agent, have been submitted for the review of Ben A. Montenegro of Montenegro, Thompson, Montenegro & Genz, General Counsel to the Brick Utilities; and

**WHEREAS**, it has been determined that the lowest responsible and responsive bid received in response to the bid solicitation is as follows:

**WHEREAS**, the term of the Contract for supply of Electrical Work with the above noted vendor shall be from May 1, 2017 through April 30, 2018; and

**WHEREAS**, John Clifford, Chief Financial Officer, has advised that the Brick Utilities has budgeted funds in various Operating and Capital Accounts in the 2017/2018 Budget.

**NOW, THEREFORE, BE IT RESOLVED** this 27<sup>th</sup> day of April, 2017, by the Brick Township Municipal Utilities Authority, as follows:

1. The Authority accepts and approves the low bid submitted by the above referenced bidder, Starlite Electric, LLC, at the rates set forth hereinabove, with the understanding that all rates shall be at least the minimum prevailing wage rate as determined for the County of Ocean and County of Monmouth.
2. That the contracts for Electrical Work be, and hereby are, awarded subject to all conditions outlined in the attached Notice to Bidders and Specifications.
3. The Chairman, Qualified Purchasing Agent, Executive Director and Secretary be and hereby are authorized to execute any and all necessary documents in order to implement the intent of this Resolution.
4. That the Qualified Purchasing Agent be and hereby is authorized to return the bid bonds and other securities received from the unsuccessful bidders within the three (3) days after execution of the contracts and to notify all bidders of the award of the contract.
