A Resolution for Award of Bid for Water and Sewer Pipe and Appurtenances

WHEREAS, the Brick Township Municipal Utilities Authority (“Brick Utilities”), pursuant to Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. duly advertised for bid for Water and Sewer Pipe and Appurtenances; and

WHEREAS, three bids were received pursuant to the advertisement and publicly opened on July 12, 2017 at 10:00 a.m.; and

WHEREAS, said bids and a recommendation from Qualified Purchasing Agent Robert W. Bowers have been reviewed by the Brick Utilities and bid packages having been submitted for the review of Ben A. Montenegro of Montenegro, Thompson, Montenegro & Genz, General Counsel to Brick Utilities; and

WHEREAS, bids were requested for a total of 21 items; and

WHEREAS, no bids were received for Item No. 18 and staff will go out for quotes on this item, if and when deemed necessary; and

WHEREAS, Atlantic Plumbing Supply Corporation, did submit a responsive and responsible bid and is low bidder for Item Nos. 1 and 8; and

WHEREAS, Cutter Drill & Machine, Inc. did submit a responsive and responsible bid and is low bidder for Item Nos. 5, 6, 9, 13, 14, 15, 16, 17, 19, 20 and 21; and

WHEREAS, HD Supply Waterworks, Ltd. did submit a responsive and responsible bid and is low bidder for Item Nos. 2, 3, 4, 7, 10, 11 and 12; and

WHEREAS, the term of the Contract with Atlantic Plumbing Supply Corporation, Cutter Drill and Machine, Inc. and HD Supply Waterworks, Ltd. shall be for one year from the date of award; and

WHEREAS, John Clifford, Chief Financial Officer, has advised the Authority that sufficient funds for the payment of \$25,375.10 do exist for payment of these contracts.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Brick Township Municipal Utilities Authority as follows:

1. That the Contract for the Pipe and Appurtenance Item Nos. 1 and 8 for a total bid amount of \$1,744.50 is awarded to Atlantic Plumbing Supply Corporation in accordance with the attached Bid Award Sheet; and
2. That the Contract for the Pipe and Appurtenance Item Nos. 5, 6, 9, 13-17, 19-21 for a total bid amount of \$12,026.32 is awarded to Cutter Drill & Machine, Inc. in accordance with the attached Bid Award Sheet; and
3. That the Contract for the Pipe and Appurtenance Item Nos. 2, 3, 4, 7, 10, 11 and 12 for a total bid amount of \$11,604.28 is awarded to HD Supply Waterworks, Ltd. in accordance with the attached Bid Award Sheet; and
4. The Qualified Purchasing Agent be and is hereby authorized to notify all bidders of the award of these contracts.
5. The Authority's Chairman and Secretary are hereby authorized to execute contracts and any necessary documents in furtherance of the contract awards to the three low bidders herein.
