BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY

A Resolution Awarding the Contract for the Supply of One (1) 2018 Low Pro Cab Chassis with Utility Body to Metropolitan Truck Sales, Inc. in the Purchase Amount of \$129,900.00; Capital Project No. 817003

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has solicited bids for the purchase of One (1) 2018 Low Pro Cab Chassis with Utility Body; and

WHEREAS, bids for the contract have been solicited by the Authority in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, two (2) bids were received on August 22, 2017 in response to the bid solicitation, as follows:

1. **Metropolitan Truck Sales, Inc.** \$129,900.00
2. **Maurice Schwartz & Sons** \$132,987.00

WHEREAS, the bid submitted by Metropolitan Truck Sales, Inc., the apparent lowest responsible bidder, has been reviewed by the Authority's solicitor and its administrative staff, and found to contain no material defects mandating rejection; and


WHEREAS, Brick Utilities Chief Financial Officer, John Clifford, has advised that sufficient funds for the payment of \$129,900.00 is accounted for in the Authority's Capital Budget within Capital Project No. 817003.

NOW, THEREFORE, BE IT RESOLVED this 28th day of September, 2017 by the Brick Township Municipal Utilities Authority as follows:

1. The Authority accepts the recommendations of the Authority's solicitor and administrative staff and awards the contract for this purchase to Metropolitan Truck Sales, Inc., and in consideration of \$129,900.00.

The proper officers of the Authority are authorized to execute any and all necessary documents to enter into Contract for the purchase of one (1) 2018 Low Pro Cab Chassis with Utility Body with Metropolitan Truck Sales, Inc., 1360 Route 88 West, Lakewood, NJ 08701 subsequent of same by the appropriate officials of Metropolitan Truck Sales, Inc.


