A Resolution Awarding the Contract for the Supply of One (1) 2019 Hino Model 338 – 6-Yard Dump Body to Metropolitan Truck Sales, Inc. in the Purchase Amount of \$101,695.00; Capital Project No. 817005

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the “Authority”) has solicited bids for the purchase of One (1) 2019 Model or Newer 6-Yard Dump Truck; and

WHEREAS, bids for the contract have been solicited by the Authority in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, two (2) bids were received on November 27, 2017 in response to the bid solicitation, as follows:

WHEREAS, the bid submitted by Metropolitan Truck Sales, Inc., the apparent lowest responsible bidder, has been reviewed by the Authority’s solicitor and its administrative staff, and found to contain no material defects mandating rejection; and


