A Resolution Appointing Maser Consulting, P.A. as the Consulting Engineer to The Brick Township Municipal Utilities Authority for the term of February 1, 2018 through January 31, 2019

WHEREAS, there exists a need for consulting engineering services by the Brick Township Municipal Utilities Authority; and

- Maser Consulting, PA, 331 Newman Springs Road, Suite 203, Red Bank, NJ 07701 is hereby appointed as the Consulting Engineer to the Brick Township Municipal Utilities Authority from February 1, 2018 until January 31, 2019, or until the first meeting of the Authority after such date.
- The Authority Chairman and Secretary are hereby authorized and directed to execute an Agreement for Professional Services with said firm, with a fee schedule in accordance with the RFQ for professionals/consultants.
- 3. This contract is awarded without competitive bidding as a "professional service" in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts Law.
- The offices of Maser Consulting, PA. shall maintain at all times during the term of this
  employment adequate Professional Liability Insurance including, but not limited to, an
  Errors and Omissions Policy in an amount in accordance with the RFQ for
  professionals/consultants.
- 4. The Executive Director shall cause notice of award of said appointment to be published once in the official newspaper of the Authority.
