

**RESOLUTION NO. 35-18**

**THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**March 29, 2018**

**A Resolution Awarding Bid for Water Treatment Chemicals**

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as the “Authority”) has solicited bids for the supply of water treatment chemicals for Fiscal Year 2018/2019 [April 1, 2018 to March 31, 2019]; and

**WHEREAS**, bids have been solicited by the Authority for the project in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11 et seq., and

**WHEREAS**, at the solicitation/opening on March 6, 2018, no bids were received for Item 8 - Carbon Dioxide, requiring a re-bid for Item 8 – Carbon Dioxide, with said opening on March 27, 2018 in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, the bids have been carefully reviewed by Joseph Maggio, P.E., Director of Water Quality, as well as by the Authority Solicitor, and a recommendation has been made to the Commissioners by Director Maggio as to the lowest responsible bidder for each of the chemicals, as follows:

6. Zinc Orthophosphate	Shannon Chemical Corporation	\$88,440 (7.37/gallon)
7. Aqua Ammonia	Coyne Chemical Co., Inc.	\$16,575 (2.55/gallon)
8. Carbon Dioxide	Praxair, Inc.	\$121,000 (220/ton)

**WHEREAS**, the bid documentation submitted by each of the above lowest responsible bidders for each of the particular chemical supplies has been reviewed by Director Maggio and the Authority Solicitor and has been found acceptable as to form and content, and is in compliance with the bid specifications; and

**WHEREAS**, the low bid for Zinc Orthophosphate (\$65,490.) has been rejected as materially nonresponsive to the specification requirement that the source of zinc be zinc oxide; and

**WHEREAS**, John Clifford, Chief Financial Officer, has advised Brick Utilities that funding for the purchase of the aforesaid chemicals have been included in the 2018/2019 Authority Operating Budget, Account Number 8330-700-01; and

**WHEREAS**, any 2018/2019 budget overrun for chemicals will be accounted from within other 2018/2019 operating accounts;

**NOW, THEREFORE, BE IT RESOLVED** this 29<sup>th</sup> day of March, 2018, by the Brick Township Municipal Utilities Authority as follows:

1. The contracts for the chemicals be and hereby are awarded as hereinabove set forth, subject to all conditions outlined in the Notice to Bidders and Specifications.

2. The Chairman and Executive Director and Secretary of the Authority be and hereby are authorized to execute any and all necessary documents in order to implement the intent of this resolution.


3. The Executive Director be and hereby is authorized to return the bid bonds and other security received from the unsuccessful bidders within three (3) days after execution of the contracts, and to notify all bidders of the award of these contracts.
