THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY

March 29, 2018

A Resolution Rejecting all Bids for the Roofing Replacement Project – Project No. 917001

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the “Authority”) has solicited bids for the Roofing Replacement Project - Project No. 917001 (hereinafter “Roofing Replacement Project”); and

WHEREAS, bids for the Contract have been solicited by the Authority in conformance with the provisions of the New Jersey Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, bids were received March 8, 2018 in response to the bid solicitation, as follows:

1. Kowalski Roofing Corp.	\$77,930.00
2. D.A. Nolt	\$128,140.00
3. NDP Construction, LLC	\$134,092.85
4. Roof Management, Inc.	\$2,607,738.10

WHEREAS, N.J.S.A. 40A:11-13.2 provides the bases upon which a contracting unit may reject all bids, including when the lowest bid substantially exceeds the cost estimates for the goods/services; and

WHEREAS, all bids substantially exceed the cost estimates for the project; and


NOW, THEREFORE, BE IT RESOLVED this 29th day of March, 2018, by the Brick Township Municipal Utilities Authority as follows:

1. The Authority rejects all bids submitted for the Roofing Replacement Project.
2. The Commissioners authorize staff, in consultation with its professionals to review the bid documentation and determine in their discretion whether to immediately re-bid; or that the specifications should be substantially revised; and/or whether the Authority can utilize a state authorized contract pursuant to N.J.S.A. 40A:11-12.
3. The Authority authorizes and directs the Chairman, Executive Director, and Secretary to execute any and all necessary documents in order to implement the intent of this Resolution.
