THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY

A Resolution Authorizing and Approving a Shared Service Agreement with the Township of Brick for Health Screening Services by the Township Emergency Medical Technicians (EMTs)

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the “Authority”) has been involved in discussions with representatives of the Township of Brick (hereinafter referred to as the “Township”) for the sharing of services involving health screening services by the Township Emergency Medical Technicians (EMTs); and

WHEREAS, the Township makes use of its Emergency Medical Technicians (EMTs) for the health screening of its employees at the start of each workday; and

WHEREAS, the Authority is in need of such services for its employees which can be provided by the Township of Brick; and

WHEREAS, the Authority believes that the proposed Shared Services Agreement is fair and equitable to both parties, and will be in the best interests of the Authority and its employees; and

WHEREAS, the Shared Service and Consolidation Act and N.J.S.A. 40A:65-1, et seq., authorizes the Authority to enter into a contract for the provision of the services as set forth herein with the Township of Brick; and

WHEREAS, N.J.S.A. 40A:65-6 requires that such a contract be authorized by Resolution; and

WHEREAS, pursuant to N.J.S.A. 40A:65-1 et seq., municipalities and other local government units may enter into agreements with shared services with other municipalities and local governmental units to provide or receive any services that the local unit participating in the agreement is empowered to provide or receive within its own jurisdiction; and

WHEREAS, the agreement must comply with the requirements of N.J.S.A. 40A:65-7 and specify the services to be performed under the agreement, procedures of payment and assignment and allocation of responsibility for meeting standards between and among the parties; and

WHEREAS, the Agreement has been carefully reviewed by the Commissioners and found to be acceptable as to form and content; and

WHEREAS, the Authority began implementing the terms and conditions of the Agreement as of April 20, 2020.

NOW, THEREFORE, BE IT RESOLVED this 30th day of April, 2020 by Brick Township Municipal Utilities Authority as follows:

1. The Authority, through its Board of Commissioners, does hereby authorize and confirm the execution of a Shared Service Agreement with the Township of Brick for the services as set forth herein. A true copy is on file at the office of the Administrator and Secretary of the Authority and can be reviewed during normal business hours.
2. The Authority authorizes and directs the Chairman, and Secretary to execute any and all necessary documents in order to implement the intent of this resolution.

3. The Authority hereby ratifies the implementation of the terms and conditions of the Agreement as of April 20, 2020.
