RESOLUTION AUTHORIZING CHANGE ORDER NO. 1 FOR AN INCREASE TO THE CONTRACT WITH AUTOMATED CONTROL CONCEPTS (ACC), INC. IN THE AMOUNT OF \$17,395.00 FOR THE GRANULAR ACTIVATED CARBON (GAC) IMPROVEMENTS AT THE WILLIAM MILLER TREATMENT PLANT - CAPITAL PROJECT NO. 717003: NJIB PROJECT NO. 1506001-011

WHEREAS, The Brick Township Municipal Utilities Authority (the "Authority") did enter into a contract with ACC to perform SCADA Integration for the Granular Activated Carbon (GAC) Improvements at the William Miller Treatment Plant (Capital Project No. 717003: NJIB Project No. 1506001-011) which contract was authorized by Resolution 80-19; and

WHEREAS, there have been modifications to the project scope of work which have resulted in increases to labor and material costs necessitated a change order; and

WHEREAS, said changes are shown on a document entitled Change Order No. 1 dated December 14, 2020 with the changes totaling \$17,395.00; and

WHEREAS, said Change Order No. 1 provides for an increase of the contract amount by \$17,395.00 from the previously approved original contract amount of \$88,200.00 resulting in a new contract amount of \$105,595.00; and

WHEREAS, the Authority and ACC. have agreed to such change as fair and reasonable and could not have been foreseen when the contract was awarded; and

WHEREAS, the Authority's Director of Compliance and Technology, Gary Vaccaro, has reviewed this change order and is recommending that it be approved; and

WHEREAS, the Authority's Chief Financial Officer, John Clifford, has advised the Authority that sufficient funds for the additional payment of \$17,395.00 do exist for Capital Project No. 717003.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY as follows:

- 1. The contract agreement between the Authority and Underground Utility Corp. is amended and the change entitled Change Order No. 1 dated December 14, 2020 may be executed by the officers and employees of the Authority subsequent to the execution of such change order by the appropriate ACC.; and
- 2. Said amount of \$17,395.00 shall be funded from Capital Project No. 717003; and
