**A Resolution Awarding a Contract for the Purchase of Uninterrupted Power Supply (UPS)
for Laboratory Equipment In the Amount of \$20,007.00 From Vendor Provantage Inc.
Funded From Account 710036A**

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as “the Authority”) is in need of Uninterrupted Power Supply (UPS) for Laboratory Equipment; and

WHEREAS, the Authority requested prices from multiple vendors for the Uninterrupted Power Supply (UPS) for Laboratory Equipment and Provantage Inc. was the lowest responsive quote; and

WHEREAS, the Authority has requested and received a price quote for the purchase of an Uninterrupted Power Supply (UPS) for Laboratory Equipment from Provantage Inc. in the amount of \$20,007.00; and

WHEREAS, the Authority, having a Qualified Purchasing Agent and making use of the State Bidding Law, the proposed purchase is exempt from public bidding requirements of the Local Public Contracts Law; and


WHEREAS, John Clifford, Chief Financial Officer, has advised the Authority that sufficient funds exist within Operating Budget Account 710036A to fund the purchase of the aforesaid Uninterrupted Power Supply (UPS) for Laboratory Equipment.

NOW, THEREFORE, BE IT RESOLVED this 25th day of March, 2021, by the Brick Township Municipal Utilities Authority as follows:

1. The Contract for the purchase of the aforesaid Uninterrupted Power Supply (UPS) for Laboratory equipment is hereby awarded to Provantage Inc. in the amount of \$20,007.00.
