**BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**A Resolution Awarding a Contract for the Procurement of Services to  
Rebuild Raw Water Pump #1 in the amount of \$28,840 from Vendor  
Universal Electric Motor Service  
Funded From Account 718-007**

**WHEREAS**, the Authority seeks to procure services to Rebuild Raw Water Pump #1;  
and

**WHEREAS**, the Authority has requested and received a price quote for the services to  
rebuild Raw Water Pump #1 from Universal Electric Motor Service in the amount of \$28,840;  
and

**WHEREAS**, the Authority, having a Qualified Purchasing Agent and making use of the  
State Bidding Law, the proposed purchase is exempt from public bidding requirements of the  
Local Public Contracts Law; and

**WHEREAS**, John Clifford, Chief Financial Officer, has advised the Authority that  
sufficient funds exist within Capital Budget Account 718-007 to fund the procurement of  
services to rebuild the aforesaid Raw Water Pump #1.

**NOW, THEREFORE, BE IT RESOLVED** this 27th day of May, 2021, by the Brick  
Township Municipal Utilities Authority as follows:

1. The contract for the purchase of the aforesaid services is hereby awarded to Electric  
Motor Service in the amount of \$28,840.00.
2. The Chairman and Executive Director and Secretary of the Authority be and hereby are  
authorized to execute any and all necessary documents in order to implement the intent of  
this resolution subsequent to the execution of same by Universal Electric Motor Service.
